ANNIE
Always go with the dog, honey. I'm going to use the restroom. Be back in a minute.

She heads for the back of the lobby as Dan heads for the front doors. He CROSSES IN FRONT OF Callen and Sam, doing their best to blend in as they search the crowd.

~~SAM
We're looking for anyone suspicious. Nobody carrying something that could conceal an assault weapon.~~

ON SAM as he opens his eyes. Dust fills the air. Debris all around him. He starts to turn himself over.

SAM'S POV as he looks up toward the ceiling. He can see people running past. MUFFLED SCREAMING and YELLING fades in.

He looks over to see Callen picking himself up, in a daze. They lock eyes.

And then a shopper runs into Callen in a panic. Both of them fall to the floor. The AURAL CHAOS of the mall SLAMS BACK in full surround sound.

Callen stands as Sam helps the panicked shopper to her feet. It's the fiancée, Annie, whom we saw in Act Three.

ANNIE

My boyfriend! He went back to the car!

Sam looks toward the destroyed exit. Bodies lay around it.

SAM

It's okay, I'm sure he's safe. Stay right here.

A BLOOD-CURDLING SCREAM! They turn to see a WOMAN on the ground. She's looking at something a little ways away--

A SEVERED LEG from Jalal.

CALLEN

Sam, he didn't have a detonator.

SAM

I didn't see a timer either.

CALLEN

He asked us for help...

SAM

Remote detonation. The exits could be wired.

Callen touches his earwig. Sam tries his, too.

CALLEN

Give it to me.

She hands the radio over.

MORALES

His name is Rick. He's based off-
site.

CALLEN

(into radio)

This is NCIS Agent Callen. Rick,
are you there?**3/5**

Yes, I'm here.

Callen hands the radio back to Morales.

CalLEN
We need to keep people away from the exits.

FYI

Morales nods, gets to work. Callen heads over to Sam, who is checking Dan's pulse.

SAM
He's alive, but his pulse is weak.

KENSI (V.O.)
(over earwig, distorted)
Callen, Sam? Do you copy?

PA SYSTEM (V.O.)
Attention, Shoppers. For your safety, please stay away from the exits.

CalLEN
Kensi? Kensi, are you okay?

PA SYSTEM (V.O.)
Do NOT attempt to exit. I repeat: Do NOT attempt to exit.

INTERCUT WITH:

Kensi and Deeks are heading toward the doors.

KENSI
Callen, thank God. Are you two okay?

CalLEN
Yeah, but we got a lot of injured people in here.
